

FERNDALE RADIO “Mini Trees” OFFICIAL CONTEST RULES

1. NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

2. Eligibility. Subject to the additional restrictions below, the FERNDALE RADIO “Mini Trees” (“Sweepstakes”) is open to legal U.S. residents of Michigan who are 18 years or older at the time of entry. Employees and contractors of Ferndale Radio, (“Sponsor”), Rust Belt Market, Kickstand Productions, the Lager House and each of their respective affiliated companies, and advertising and promotional agencies, and the immediate family members of, and any persons domiciled with, any such employees or contractors, are not eligible to enter or to win.

3. How to Enter. The Sweepstakes will begin at 12:00 a.m. ET on July 29, 2026 and ends at 11:59 p.m. (ET) on September 9, 2026 (the “Entry Period”). Enter online by visiting www.ferndaleradio.com. Each entrant will need to complete an online entry form with their contact information (name, address, phone and email address), any other required information, and follow all posted instructions. To submit your entry click the “SUBMIT” button. Multiple entrants are not permitted to share the same email address. Maximum one (1) entry per person. Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of entry tracking. Ad blocking software on your computer needs to be disabled so that it doesn’t interfere with processing your entry. Sponsor will not be responsible for incomplete, late, lost, misdirected or illegible entries. By entering, you agree to the terms of these Official Rules and to receive emails from Sponsor or those directed by Sponsor. You may opt-out of receipt of the emails by following the directions in any email received from Sponsor. All entries become property of Sponsor and none will be returned. Any questions regarding the number of entries submitted shall be determined by Sponsor in its sole discretion, and Sponsor reserves the right to disqualify any entries by persons determined to be tampering with or abusing any aspect of the Sweepstakes.

4. Winner Selection. On or about September 10, 2026, five (5) winners will be selected in a random drawing from among all eligible entries received.

5. Prizes and Odds. Five (5) grand prize winners will each receive a pair of tickets to see Mini Trees on September 16, 2026, at the Lager House in Detroit, Mich. (ARV: \$49.80 per prize). 6. Winner Notification and Acceptance. Winners will be notified on or about September 10, 2026, at the telephone number or email address provided on winner’s entry form. Sponsor will contact winner during regular business hours at number provided on entry form and will leave no messages. Failure to reach winner by phone, email notification being undeliverable, or failure of winner to respond to email notification within 48 hours of the time the notification was sent, may result in disqualification of winner, forfeiture of his or her interest in all prizes, and selection

Sponsor reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Sweepstakes as solely determined by Sponsor. In the event the Sweepstakes is compromised by tampering or other causes beyond the reasonable control of Sponsor which corrupts or impairs the administration, security, fairness or proper operation of the Sweepstakes, Sponsor reserves the right in its sole discretion to suspend, modify or terminate the Sweepstakes.
